Compliance Inspection Results 3rd Quarter of Fiscal Year 10/11

Report Contents and Explanation

SYNAR Inspection Results by Outlet - Federal law dictates that Montana must reach an 80 percent compliance rate in order to retain Federal Block Grant Treatment Funds. Compliance is measured by conducting unannounced inspections of 575 randomly selected, licensed tobacco merchants annually. We use a federally approved process for every aspect of these inspections.

Re-Inspection Results by Outlet - As part of the state's commitment to lower the rates of sales to minors, re-inspections are conducted at up to 50% of the outlets found in violation during the random unannounced inspections. These inspections are not included in the Synar Compliance Rate calculation.

State Inspection Results by Outlet - The state conducts inspections that are not included in the Synar Compliance Rate calculation. This is another strategy employed to lower the rate of sales to minors.

Reward and Reminder Survey Program - This program covers 49 Montana Counties. Adult surveyors accompany trained minors as they attempt to purchase tobacco products from known retailers two to four times a year. No sale is ever consumated. If it appears that the clerk would not have sold tobacco to the minor, the clerk recieves a Reward postcard. The clerk is then encouraged to fill out the postcard and mail it in for a quarterly award drawing of a \$100 gift certificate. If it appears that the clerk would have sold tobacco to the minor, the clerk recieves a Reminder postcard stating Montana's Youth Access To Tobacco law. On average 4,050 surveys will be conducted each fiscal year.
