Do I need to upload clinical information with the initial request for youth currently in care?

No, you will not need to upload clinical information with the initial request. Telligen will be auto-approving cases until they reach a CSR date that is past August 1st. The first CSR date after August 1st will be when the case is reviewed for medical necessity, so clinical information will be required at that point. Please note: the Qualitrac portal will require at least one document to be uploaded in order to submit the initial request. There is no specific document that is required for this, Telligen will not be viewing it.

Will Therapeutic Group Homes receive additional funded days for discharge planning after medical necessity is not found?

No, discharge planning begins at admission.

Will I need to utilize specific Prior Authorization Request or Continued Stay Request forms?

No, these forms were moved to electronic fields in the portal after 02/28/2020. You will still need to use the Emergency 72 hr TGH Payment Authorization Request Form #009 when appropriate. What is the deadline for having current cases submitted in the Qualitrac portal?

Please have all of your cases entered into the portal by August 1st with the actual admit date entered. Telligen will begin the auto-authorization process on August 2nd.
