1: Facility Updates

I: Census remained flat over 4 quarters. Waitlist remains at zero. The facility has had applications from Montana State Hospital but not qualified based on the Nursing Care Center's admission guidelines that require a diagnosis of mental illness.

II - New / Updated Medical Staff By-Laws & Policies

I: No new updates on By-Law

II: 12 Policies were updated and presented and were not approved. Board Members need to review these policy changes before they can be permanent.

III: No Medical Staff Privileging updates

III: Key Quality Measures and Metrics

I: Falls numbers have improved as have falls with major injury. The team has focused on using the correct definition of a fall and early interventions to prevent repeat falls.

II: The facility is reporting increased suspected abuse incidents and investigating accordingly. The team has focused on the CMS definition of abuse in a long-term care facility to determine whether incidents are substantiated as abuse after the investigations. Resident-to-resident altercations represent the majority of substantiated situations at the Nursing Care Center.

III: The number of urinary tract infections has increased slightly. Given our small census numbers, only 1 or two cases can increase or decrease this number substantially. The IFC has reviewed each case and determined each case to be unrelated to infection control practices.

IV: HR: Staffing / Hiring / Turnover

I: Vacancy rate and turnover unchanged from the previous quarter. Some open positions have been filled with internal candidates.

V: Financial / Budget Update

I: General fund deficit is projected to be \$443,305.00
