CSCT is a bundled EPSDT school based rehabilitative service including: Individual Therapy, Group Therapy, Family Therapy and Community Based Psychiatric Rehabilitation and Support. CSCT reimbursement used the methodology approved through December 31, 2019, through June 30, 2020.
