NATIONAL NEWS

ACL has announced the release of the [2024–2028 Long-Range Plan \[click.icptrack.com\]](#) (LRP) for the National Institute on Disability, Independent Living, and Rehabilitation Research (NIDILRR). The plan provides a five-year agenda for advancing the work being done in applied disability, independent living, and rehabilitation research and development. The new LRP continues to emphasize research that is highly relevant to the lives of people with disabilities and the inclusion of people with disabilities.

The [Office of Special Education Programs \[click.icptrack.com\]](#) and the [Office of Educational Technology \[click.icptrack.com\]](#) at the Department of Education published [Myths and Facts Surrounding Assistive Technology Devices and Services \[click.icptrack.com\]](#) (PDF), a guidance document aimed at dispelling common misconceptions regarding assistive technology (AT). The document is designed to increase understanding of the Individuals with Disabilities Education Act (IDEA) AT requirements, describe and dispel common myths about AT and how and when it should be deployed in schools, and provide examples of the use of AT devices and services for children with disabilities. The guidance also covers common misconceptions around costs and funding for AT devices and services.

The number of people who voluntarily quit their job in December fell to 3.4 million, the lowest in nearly three years. The number of job openings rose to 9 million, the highest level in three months.
