- Olmstead LC 3482 is the Olmstead bill the committee has been working on with DPHHS.
- Membership Committee has reached out to potential new members and will continue recruitment efforts.

Centers for Independent Living (CIL) Reports

- LIFTT:
 - Experiencing an increased demand for IL services in the areas of housing and transition to adulthood.
 - Completed PPR in December.
 - Hiring for IL Specialists in Billings and Glendive offices.
- Ability Montana:
 - Focus on peer groups meetings happening in-person, and some virtually.

- Facilitating classes such as Living Well at the Lewis & Clark jail and Ignite class at Ennis High School.
- Developed a virtual book club, chess club, and Dungeons and Dragons group as well as facilitating adaptive skating this winter and plan to have fly fishing camps this summer.
- Consumers continue to struggle with housing.
- Will be participating in Gallatin County Commission meeting regarding transit system.
- Testifying at the Capitol during legislative session 2023.
- Summit:
 - Hiring in Kalispell and Missoula.
 - Started LGBTQ group peer meetings in Missoula and Hamilton
 - BASE group is expanding. Purchased a new camera for creating short films with Christopher Reeves grant.
 - More outreach to rural communities, especially Sanders County as well as Libby and Troy.
 - Encouraging consumer participation in legislative session 2023.
 - Met with public transit provider in Missoula to do accessibility training.
 - Two peers developed a training for IL skills to do technology for blind and low vision consumers.
- NCILS:
 - Held first quarterly meeting with local leaders and legislators on December 15, 2022.
 - Homelessness is a big issue for consumers.
 - Completed trainings related customized employment and Transcend and partnered with Jean and the Empowerment Center around youth and family engagement initiatives.
 - Working with local Transportation Advisory Committee.
