NATIONAL ITEMS OF INTEREST

U.S. Access Board Webinar: Accessible Exterior Routes and Surfaces - People who use mobility devices and canes access buildings and facilities by traversing accessible routes and ground surfaces at the site arrival to the entrance. These exterior routes and surfaces must comply with technical requirements in the [Americans with Disabilities Act \(ADA\)](#) and the [Architectural Barriers Act \(ABA\) Standards](#). The next webinar in the U.S. Access Board's free monthly series will take place **May 4** from **2:30 – 4:00 (ET)** and address the ADA and ABA Accessibility Standards for exterior routes and surfaces, including the differences between accessible routes for building sites, outdoor recreation areas, trails, and beaches. Additionally, Board Accessibility Specialists will share information on the concepts of stable, firm, and slip resistant surfaces in the outdoor environment, as well as review playground surfaces.

General Services Administration Publishes Section 508 Program Maturity Reports - General Services Administration (GSA) recently published Section 508 Program Maturity Reports (PMR) from 2019 – 2022 on [Section508.gov](#). Federal agencies are required to report to the Office of Management and Budget (OMB) twice per year on their Section 508 program maturity and effectiveness. The PMR include compliance with the [U.S. Access Board's Section 508 Standards](#), development of measures for progress, and implementation of regular assessments. The PMR helps to ensure the accessibility of information and communication technology (ICT) in the federal government.

GSA's Government-wide IT Accessibility Program analyzes the agency reporting and compiles the data to identify ways to increase collaboration across agencies, reduce redundancies, and develop solutions to improve the management of government accessibility programs. Executive summary reports, along with a companion supplemental report, are provided to OMB, the Board, and Chief Information Officers Council Accessibility Community of Practice.

Administration for Community Living Issues Grant Opportunity on Universal Access to Information and Communication Technology - Administration for Community Living (ACL) has published a [grants notice](#) to fund a Rehabilitation Engineering Research Center (RERC) that addresses the universal accessibility and usability of information and communication technology (ICT) for people with disabilities. The purpose of this RERC is to conduct research and development that ensure accessibility standards are met or exceeded for ICT, promote availability and usability of individualized ICT configurations for people with disabilities, and identify barriers to sustainable innovations that provide universal access to ICT. The grant will have a 60-month project period, requiring five 12-month budget periods.

Grant applications are due **June 05, 2023** via electronic submission. Eligible applicants, details about the grant, and other information can be found on [Grants.gov](#).

The [RERC program](#) is part of ACL's [National Institute on Disability, Independent Living, and Rehabilitation Research \(NIDILRR\)](#), the federal government's primary disability research organization. NIDILRR's mission is to generate new knowledge and to promote its effective use to improve the abilities of individuals with disabilities to perform activities of their choice in the community, and to expand society's capacity to provide full opportunities and accommodations for its citizens with disabilities.

In support of this mission, NIDILRR sponsors RERCs to address the barriers confronted by people with disabilities and improve the effectiveness of services authorized under the Rehabilitation Act. RERCs also demonstrate and evaluate technologies, facilitate service delivery system changes, stimulate the production and distribution of new technologies and equipment in the private sector, and provide training opportunities.

NET UPDATES

United States Postal Service (USPS) -The NET is developing a national partnership with the Post Office. USPS has several career opportunities but is a separate personnel system from OPM. In a meeting with them they explained changes in their process and will be working with the NET to connect hiring at their headquarters as well as across the country where they have fifty local HR teams. One point of clarification - they do not use Schedule A. There is information below and a link to learn more about careers, search for jobs, how to apply and take an exam.

There are four entrance exams, which are non-proctored. You can provide support to candidates taking the exams. The exams are each about an hour in length. There are fifty local HR teams – we will be working on making connections with NET members across the country.

RAVE (retaining a valued employee) is a no cost, Vocational Rehabilitation service for employers that helps better manage disability in the workplace, lower disability-related costs, and retain valued employees whose job performance is impacted by illness, injury, or disability. Learn how your company can work with a business relations consultant and a rehabilitation engineer to help determine the right accommodation for your employees to be successful in their roles!

Lastly, hear from Alabama's AT Act director on services available through the federally funded program which aims to expand assistive technology services in the state. Learn about their APT AT projects such as device loans for trial before you buy, device demonstrations to help you make informed decisions, and training for professional development. Let's discuss how your organization can partner with APT AT to develop and expand your assistive technology implementation services.

It is our hope that this informational webinar will encourage you to work with the Alabama Department of Rehabilitation Services by utilizing the services and resources available to help retain your employees with disabilities.
