### **NATIONAL NEWS**

February is [Career and Technical Education \(CTE\) Month \[click.icptrack.com\]](#), hosted by the Association for Career and Technical Education, which recognizes the accomplishments of CTE programs and the importance of CTE to students of all ages and abilities. CTE refers to courses and programs which prepare students for careers in current or emerging professions. Students who complete CTE programs can earn certificates, licensure, and postsecondary degrees in their field, and find jobs in areas of high need like health sciences and audio-visual technology.

CTE can offer students with disabilities in high school and beyond an opportunity to personalize their education based on their career interests and unique learning needs.

These students can face challenges in accessing CTE programs, such as inaccessible facilities, teachers who are not familiar with working with students with disabilities and integrating CTE into individualized education plans.

Some of you are reviewing financial need policies that you have in place. This is certainly a good time to be doing this review. Much financial needs testing has been directed at college tuition. Here is something to keep in mind. Per *The Wall Street Journal* less than half the usual number of high school student have applied for college financial aid so far this year after a glitch-filled rollout of the government's revamped FAFSA. About 7,000 seniors have completed applications, down from 1.5 million applicants the same time last year. As you look at potentially lifting or diminishing any financial need policy, please do your homework in terms of the projected fiscal impact. Will it get you where you want to be or not.

## **RSA UPDATE**

The U.S. Departments of Education and Labor (the Departments) issued a [final rule \[federalregister.gov\]](#) in the Federal Register (89 FR 13814) that defines the sixth performance indicator - effectiveness in serving employer - as *Retention with the Same Employer* and requires it be reported by one WIOA core program on behalf of all six WIOA core programs within each state. The [final rule \[federalregister.gov\]](#) is effective March 25, 2024.

RSA published the [SAM for Program Years 2024 and 2025 \[rsa.ed.gov\]](#). The [SAM \[rsa.ed.gov\]](#) provides the first set of *Estimated Levels of Performance*, including the coefficients and State-specific values for each variable, for each of the five performance indicators. It is important to note that this estimate is but one of the factors RSA must consider in establishing *Negotiated Levels of Performance*. For information related to the other factors (e.g., continuous improvement), please see pages 9-10 of [TAC-20-02 \[rsa.ed.gov\]](#). In early April, RSA will contact the director(s) of each State VR program to propose *Negotiated Levels of Performance*. By mid-April, they will ask that State VR programs either accept their proposals or request further negotiation. If State VR programs request further negotiation, [RSA State Teams \[rsa.ed.gov\]](#) will schedule meetings soon thereafter.
