**OSEP and RSA Host Webinar - Beyond the IDEA and WIOA Requirements: Knowing what to expect when it matters.** OSEP Director, Valerie Williams and RSA Commissioner, Dante' Allen hosted a webinar that featured a panel highlighting the

partnership between schools and VR to raise expectations, engage families and support career planning and transition for students with disabilities. The session was recorded. This session featured a partnership in New York and Oregon. The Oregon partnership highlighted an individual who was supported by his school and both the OCB and OVR as he transitioned into a career pathway.

## White House Convening on Protecting the Safety, Rights and Dignity of Air Travelers

U.S. Department of Transportation – Notice of Proposed Rulemaking, Travelers who use Wheelchairs and Mobility Devices. Passengers who use wheelchairs often face accessibility barriers during air travel. In fact, more than 10,000 wheelchairs and other mobility devices are mishandled or damaged every year during air travel. In response to this, the U.S. Department of Transportation (DOT) has issued a Notice of Proposed Rulemaking (NPRM) [Inks.gd] that would dramatically expand the rights and protections of airline passengers who use wheelchairs.

# NET UPDATES

**ODEP – NET Collaboration state liaisons careers through infrastructure funding.** ODEP reached out to make sure that VR representative from the NET were represented as a partner on a project that is focused on career opportunities that are supported through the infrastructure funding, such as transportation and alternative energy. The NET points of contact in Alabama, Arizona, Georgia, Michigan, Nevada, North Carolina, Pennsylvania and Virginia were introduced to the DOL representatives that are team leads/facilitators for the workgroups with the goal of collaborating across systems to include candidates with disabilities.

**EARN Webinar: March 27<sup>th</sup>.** ODEP and the EARN team reached out to invite the NET, VR agency Business Specialists and a business partner to present at an EARN Webinar on March 27. The session, titled **"Small Business Webinar - Tapping into Talent Through Community Partners"** is designed to introduce national, state and local level strategies and resources that support businesses of all sizes. This webinar will highlight the NET and Business Relations Reps from VA-B and CO-VR as well as a small business partner. **CVS Hires – Data Collection.** The NET is collecting data on the hires within CVS companies across the country. The CVS Health team has new leadership who is interested in learning more about successful partnerships and how they support the company. The NET points of contact are gathering data to send to Kathy. They are also sharing examples of strategies that support career development. Hawaii shared their hires but also great examples of workplace learning strategies: 28 students and 3 adults being served by VR participated. There were 14 students who participated in Job Shadowing, four in work-based learning, seven in the Summer Youth Employment Program and three in Internships. Three adults had the opportunity to participate in paid work experiences. These opportunities contributed to career development and also resulted in hires.

**Direct Interactions – WA DVR Partner.** Direct Interactions, a long-time partner of WA-DVR, is a customer service and technical support company that includes work from home opportunities as well as in-person. The Department of Social and Health Services (the umbrella agency of DVR) recognized the company with the Champion of Equity Award and the Rev Dr MLK Beloved Community

Award. <u>https://dshswa.medium.com/dshs-honors-champions-of-equity-recognizing-the-2nd-annual-rev-bac40a409f17 [dshswa.medium.com]</u>. <u>The company representative stated</u>, "we are humbled to receive this award and excited to see people with disabilities included in conversations about diversity, equity, inclusion and belonging." The company reached out to the NET and was connected to the CA-DOR representative as they expand their operations to that state. A great example of cross-state referrals and support at the national, state and local level!

**NET – Boeing Expansion.** The NET partnership with Boeing continues to grow. Inger is currently working with our NET POC in San Antonio, Texas and Mesa, AZ to create and deliver Disability Awareness Training. She is also assisting with their national Neurodiversity At Work project. Inger and Kathy will be working with the NET POC's to schedule virtual Disability Awareness training that will include the company representatives from the following states: MO, SC, FL, TX and WA.

**Survey of State Agencies Using Paid Internship Models.** Thank you to the NET Point of Contact for NJ-VR for collecting and compiling feedback on the various strategies being used by VR agencies to support paid internships. The results were shared with the NET POCs and VR Training Center Directors.

**Survey of Young Adults who are blind or have a vision loss**. The University of Illinois Urbana-Champaign is conducting a survey with young adults who are blind or have a vision loss are ages 18-25 and have graduated/left high school. This request went out through NCSAB and the NET. There is additional information below and attached as well as a link for any questions, highlighted below.
