## NATIONAL NEWS

The big event has arrived! This coming week have 170+ people attending the NET Summit, not counting our business/federal partners. Thank you for your response and thanks to our team -- - Kathy, Tonia, Theresa and Inger --- for the work to support the recruit and confirm presenters, registration, hotel accommodations, agenda, etc. Thanks also to Michael MacKillop and Toni Wolfe, the Chairs of the Careers and Business Relations Committee who have worked with the team to put this great event together.

In late August SSA proposed a new rule to alter benefit payments for those who receive what's known as "in-kind support and maintenance" in the form of a rental subsidy. Under current rules, SSI benefits are reduced if a person is paying rent or shelter expenses that are lower than the current market value, or what they would pay on the open market. Now, the agency wants to update its rules to treat beneficiaries nationwide more equitably. SSA estimates that about 41,000 current SSI beneficiaries would see their monthly payments rise under the rule change by an average of \$128 per month. And, some 14,000 individuals who don't receive SSI now would be able to qualify for the program as a result of the update.

Some interesting tidbits:

- Between the pre-pandemic month of January 2020 and July 2023, the immigrant labor force grew by 9.5%, compared with a 1.5% growth rate in the US born workforce. *Axios*
- Travel is on a pace to become a \$15.5 trillion industry – accounting for more than 11.6% of the global economy \_\_ by 2023, according to the World Travel & tourism Council. The industry will employ up to 430 million people accounting for roughly 1 of every 9 jobs globally. *Bloomberg*
- For the Starbucks drinkers. Starbucks plans to open a coffee shop in China every nine hours to reach 9,000 locations across the country by 2025. *Financial Times*
- Working from the "gym office" seems to be growing as some gyms are offering keyboard warriors who want to work close to where they work out extra desks, offices, and outlets. In addition to co-working spaces and privacy booths some gyms are even offering conference room space. *The Wall Street Journal*
- Just for fun. For those of us who are young at heart, toys for adults are on the rise. A July survey by the Toy Association found that 41% of parents have bought toys for themselves in the past 12 months and 43% plan on doing so this year. Toymakers are reportedly banking on a retro toy craze among adults after the success of movies like *Barbie* and *Transformers*. More "kidults – also known as juveniles and adultescents" are embracing their inner child. McDonald's has introduced Happy Meals for adults. Stay tuned for updated versions of the *Game of Life* and *Trivial Pursuit*.

## **PATHWAYS TO PARTNERSHIPS DIF GRANTS ANNOUNCED**

This past Friday RSA announced it will fund 20 model demonstration projects (DIFs) focused on improving economic self-sufficiency for children and youth with disabilities by creating systemic approaches to enhance post-school outcomes.

The nearly \$199 million in funding for the [Pathways to Partnerships \[lnks.gd\]](#) innovative model demonstration project supports collaborative partnerships between state vocational rehabilitation agencies, state and local educational agencies, and CILs.

Congratulations to the following states on receipt of these grants: PA, AR, LA, IL, CT, OK, WY. NM, CO, AK, SC, NJ, VT, KY, MD, NV, GA, ME, ID, KS. Of the 20 grants eight are going to VR agencies as the lead and the remaining 12 are going to state education agencies.

### **OSERS & RSA NEWS**

On October 1, 2023, RSA will begin collecting the following reports: *Annual Client Assistance Program (CAP) Report*, the *Annual Report for the Older Individuals who are Blind (OIB)*, *Independent Living Program (RSA-7-OB)*, and the *Annual Report on Appeals Process (RSA-722)* for FY 2023 in the [RSAMIS](#). These reports are due no later than December 30, 2023.

Last week RSA announced the release of the revised Vocational Rehabilitation Financial Report (RSA-17) form and instructions for the State Vocational Rehabilitation Services (VR) program. The Office of Management and Budget has approved this information collection (OMB control number 1820-0017) until September 30, 2026. The revisions to the RSA-17 are effective for the VR program for new VR grant awards issued on or after October 1, 2023 (Federal fiscal year (FFY) 2024). The RSA-17 collects semiannual cumulative VR financial data on an award-by-award basis.

RSA HAS shared an updated version of the Case Service Report (RSA-911) Data Dashboards including data reported for the fourth quarter of PY 2022. This workbook includes

performance results for all VR agencies and seven previous quarters of RSA-911 data. On the Summary tab, select a VR agency in the drop-down labeled “Agency Selection” and select a quarter in the drop-down labeled “Program Year-Qtr. Selection.” The specifications are detailed in the final tab labeled “Specs.”

The report highlights emerging benefits such as pairing ChatGPT with visual mobile assistance apps and augmentative and alternative communication, supporting students with disabilities in the classroom, and helping employees with disabilities complete job tasks. The report also explores concerns such as biases and misinformation in the data used to teach AI and potential impact on reading comprehension and other academic skills.

### **COVID**

On September 11<sup>th</sup> the FDA approved a new coronavirus vaccine. The reformulated shots target an omicron subvariant ahead of fall's respiratory virus season. Cases and hospitalizations have already been rising. The FDA cleared the shot for anybody six months and older. However, the CDC advisory panel may recommend a more targeted approach. The shot should be free for most Americans with private insurance, Medicaid or Medicare. The shot should be available now. Might be good to get it and a flu shot before coming to Savannah.
