### Publication 587 - Business Use of Your Home (See Day Care Facility)

The purpose of this publication is to provide information on figuring and claiming the deduction for business use of your home. It contains special rules for day care providers including standard meal and snack rates.

### Form W-10 (PDF)

Individuals claiming the Child and Dependent Care Credit must provide identifying information for all persons or organizations that provide care for the qualifying child. You can use Form W-10 to provide the necessary information to your clients.

The Earned Income Tax Credit is a refundable federal income tax credit for low to moderate income working individuals and families. To qualify, you must meet certain requirements and file a tax return, even if you do not owe any tax or are not required to file.
