DDP Home/Community Based Services Waiver Renewal

The Developmental Disabilities Program (DDP) offers services through what is called a Medicaid Home and Community-Based Services (HCBS) waiver. The DDP HCBS waiver is also called the 0208 or Comprehensive waiver. This waiver pays for support services to help people with developmental disabilities live in their homes and communities, instead of an institution.

Waiver services are partly paid by the federal government and partly by the state. A detailed waiver permission request is sent to the federal government for approval. This detailed request explains the kinds of support services the state wants to offer to its DDP population. Once approved, the request needs new approval every 5 years. This is called a waiver renewal.

States may ask for changes in the details of their waiver program sooner than 5 years. If a state chooses to do this, an additional permission request called a waiver amendment is needed.

The DDP's current waiver is expiring July 1, 2023. DDP is working on the renewal and asking for some changes. One change requested is the addition of behavioral services that can increase the quality of life and decrease unsafe behaviors. This could be accomplished by teaching new skills. DDP is also asking permission for parents to receive pay in some cases for providing DDP services for their children if it is above and beyond care that parents normally give. The public is invited to give feedback on the renewal request during the public comment period. The Medicaid Expansion / HELP Members will no longer be charged premiums for their coverage after 01/01/2023. Some Expansion / HELP Members were charged premiums in the past (depending on income), but that practice ended effective 01/01/2023.

WIC

WIC is a USDA-funded program that provides healthy foods to low-income pregnant and postpartum people, infants, and children up to age five. For 2023, Montana WIC is adjusting its cash-value benefit (CVB) amounts, which provides money to spend on fruits and vegetables. Members can expect the following increases: \$25/month for child participants, \$44/month for pregnant and postpartum participants, and \$49/month for fully and partially breastfeeding participants.


Community Health Data
